COUNCIL MEMBER MULDER MOVED, COUNCIL MEMBER GILLESPIE SECONDED, TO AMEND THE COMPENSATION PLAN IN ACCORDANCE WITH CITY COUNCIL PRIORITIES AND THE ADOPTED FISCAL YEAR 2023 BUDGET, BY INCREASING THE COMPLETE GRADE AND STEP SCHEDULE BY 3.5%, EFFECTIVE THE FIRST FULL PAY PERIOD AFTER 01 JULY 2022, FOR ALL FULL-TIME EMPLOYEES, BUT EXCLUDING THOSE EMPLOYEES SUBJECT TO COLLECTIVE BARGAINING AGREEMENTS AND EXCLUDING THOSE EMPLOYEES SUBJECT TO INTERLOCAL GOVERNMENTAL AGREEMENTS. MOTION CARRIED UNANIMOUSLY.
